Inspired by the possibility of saving millions of women's lives around the world, in 2010 two Cal Poly biomedical engineering students set out to design a definitive treatment for postpartum hemorrhage (PPH). Their vision led to the creation of a device that replicates the natural contraction of the uterus to rapidly stop bleeding. Through extensive research, development, and incubation with the Cal Poly Center for Innovation

& Entrepreneurship and the Fogarty Institute for Innovation, that early concept grew into the Jada[®] System—the flagship product of Alydia[®] Health. Today, Alydia Health is a privately held, venture-backed company headquartered in Menlo Park, California. Alydia Health was previously known as InPress Technologies.

THE CHALLENGE

The founders of Inpress Technologies knew they were onto something — a medical device that could treat post-partum hemorrhage, the number one cause of maternal death in the world. This device had the power to help so many women, in so many countries; this technology could not be ignored.

The challenge was the team was young. At the time it was comprised of three recent Cal Poly San Luis Obispo undergraduates with degrees in Biomedical Engineering and Business. They had theoretical experience, but not practical experience. The team knew they were going to need guidance, mentors, and experienced business consultants— they turned to the SBDC.

Simultaneously Mahan introduced the Alydia Health team to SLO Seeds a local angel group that made some of the initial investments in the company that propelled them to the next level.
