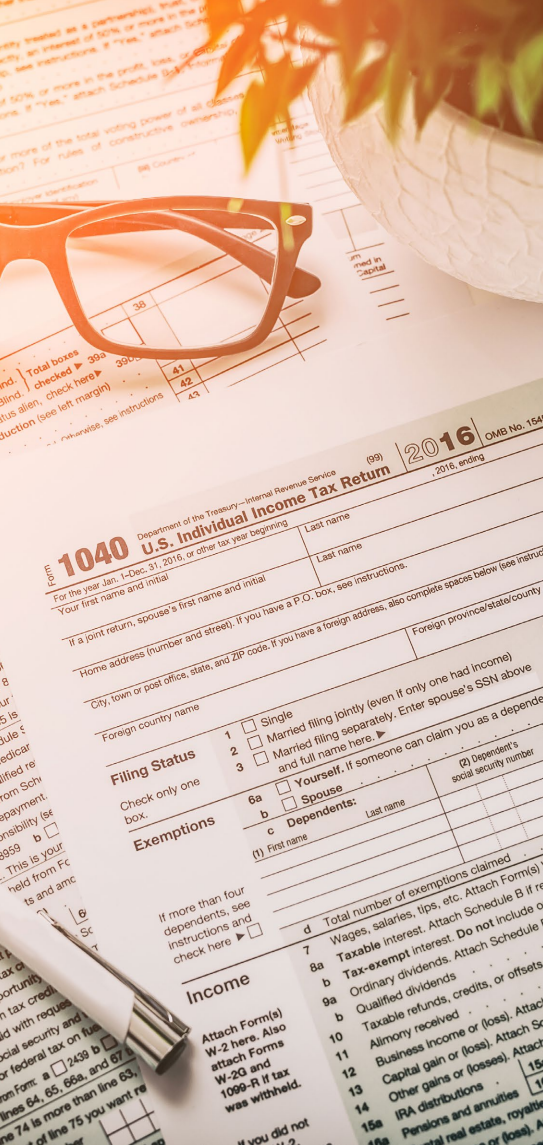
BOOK TO TAX IN MINUTES, NOT HOURS.

Tallyfor automates the tax filing process to reduce the time to file a tax return from 3 hours to 10 minutes. Tallyfor integrates

with all accounting software used to create the trial balance and efficiently produces the data for an accurate tax form.

Smooth out your busy season. Tallyfor eliminates the time-consuming process of toggling between a client's accounting system to tax forms, thereby transforming an hours-long process to just about 10 minutes.



THE CHALLENGE

Tallyfor co-founders and brothers, Peter and Ben Wen, knew they were on to something with their cloud-based tax software's ability to automate the tax filing process — saving accountants hours when filing tax returns. Their handful of clients raved about the MVP version of the software. With this traction in place and the model proving out, they realized the need to consider raising angel-backed capital to get Tallyfor to the next level.

THE SOLUTION

Peter and Ben began calling on their extensive network to strategize capital building and fundraising. Peter's former Xero colleague recommended that they apply to AngelCon 2021— a pitch competition hosted by Cal Poly's Center for Innovation and Entrepreneurship (CIE) Small Business Development Center (SBDC) where six tech-driven startups clamor for \$100,000+ in equity-backed funding. Peter immediately completed the application; two months later, Tallyfor was selected as one of six finalists.

Peter and Ben said the key to earning a spot in the finals was their participation in the Cal Poly CIE Small Business Development Center's complimentary pitch prep bootcamp. During this six-week program, 12 semifinalist startups worked hand-in-hand with veteran business consultants and past proven entrepreneurs to hone the pitch, presentation, and financials.
